All personal data supplied on the membership application form to the Hong Kong Internet Forum (HKIF) shall be treated in accordance with this Personal Data (Privacy) Notice and the Personal Data (Privacy) Ordinance (Cap 486):

A. Personal Data (Privacy) Notice

1. Personal data is collected by HKIF in order to allow HKIF to admit new members and communicate with existing members.
2. Personal data collected by HKIF may also be used to:
 - (a) verify member's credentials;
 - (b) enforce any legal or other rights HKIF may have against an applicant and/or member of HKIF in any manner that HKIF sees fit;
 - (c) send HKIF members marketing material or information relating to activities and/or objects of HKIF;
 - (d) conduct research, such as research to determine the areas of HKIF's activities which do not meet the needs and/or aspirations of HKIF members.
3. Applicants are advised to provide all the information requested in the relevant documents, where applicable, failing which HKIF may be unable to process and consider their applications.
4. Personal data supplied by applicants will be retained by HKIF and will be accessible to HKIF Committee Members and other entities engaged by HKIF to carry out work on its behalf for any of the purposes listed at paragraph 2 above.
5. Once applications have been processed
 - (a) the information collected from unsuccessful candidates will be destroyed;
 - (b) the information collected from successful candidates will be dealt with in accordance with this Personal Data (Privacy) Notice.
6. All HKIF members, former HKIF members, and unsuccessful applicants shall have the right to:
 - (a) have access to their respective personal data held by HKIF
 - (b) request correction of the information;
 - (c) be informed of any action taken in respect of such request; and/or
 - (d) request that there be attached to the information a statement which the respective member and/or former member and/or applicant will supply to HKIF relating to the fact that he/she has requested a correction of such personal data.
7. HKIF reserves the right to charge a reasonable fee for the processing of any data access or correction request.
